Greetings!

The Philippine Commission on Women would like to acknowledge receipt of the hard copy of the FY 2018 and FY 2017 GAD Plan and Budget (GPB) of Carmona City Water. District.

Please be informed that, pursuant to the issued Memorandum Circular (MC) 2015-03 – Guidelines on the Review and Endorsement of Water District Annual Gender and Development Plans and Budgets; and MC 2016-06 – Extension of the Moratorium on the PCW Review and Endorsement of Local Water District Annual Gender and Development Plans and Budgets, the PCW has suspended its review and endorsement of the GPBs and GAD ARs of water districts due to the moratorium in effect. Instead, the Local Water Utilities Administration (LWUA), as the agency that exercises regulatory jurisdiction over the water districts, shall review and endorse all GPBs and GAD ARs of water districts to PCW. LWUA may either submit the hard copy to PCW or submit thru the Gender Mainstreaming Monitoring System (GMMS) the approved GAD PB/GAD AR of a water district for record and reporting purposes. Thus, kindly submit your GPB and GAD AR to LWUA for their review, endorsement, and/or acceptance.
