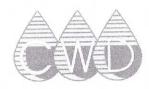

RESOLUTION NO. 025 - 2019

RESOLUTION APPROPRIATING TEN MILLION SIX HUNDRED THOUSAND PESOS (P 10,600,000.00) AS SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2019

whereas, in relation to Carmona Water District and its management's thorough review of the approved Annual Budget FY 2019, there is a need to supplement the said budget to embody changes in the annual estimates of income and appropriations during this year 2019. Any increase in the approved operating budget shall require submission and approval of a supplemental budget to cover the additional expenditures;

WHEREAS, changes in the annual budget may be made within the fiscal year by way of supplemental budgets which shall be enacted in the same manner as the annual budget but not oftener than once a month. In addition, Section 70 of the General Provisions under the National Expenditures Program of the government FY 2019 prescribes the following:

- a.) Modification in the allotment, i.e., Change in the details of an activity or project without changing its nature and within the same operating unit and change in the object of expenditure (Salaries and Wages, Traveling Expenses, or Investment Outlays) within an allotment class (Personnel Services, MOOE, or Capital Outlays) shall be subject to the approval of the heads of the agencies;
- b.) All modifications within and to Capital Outlays may only be made until June 30, 2019 except if due to the occurrence of calamities;

WHEREAS, after careful review of the available historical data and trends highlighting the results of financial performance and position of Carmona Water District for the period January 2019 to June 2019 and upon advice of the Corporate Budget Officer, CWD has projected Unappropriated Surplus in the amount of Thirty Eight Million Six Hundred Sixty

RESOLUTION NO. 018 - 2019

RESOLUTION APPROPRIATING FOUR MILLION PESOS (P 4,000,000.00) AS SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2019 INTENDED FOR THE PURPOSE STATED IN THE SUPPLEMENTARY PROCUREMENT PLAN, COPY OF WHICH IS HERETO ATTACHED AS ANNEX "A", FUNDS SHALL BE TAKEN FROM THE UNAPPROPRIATED SURPLUS

WHEREAS, Carmona Water District has received numerous complaints from the past few days from the residents of Brgy. Bancal stating their problems on the sufficiency of potable water supply attached as Annex "A-1" to "A-13";

WHEREAS, upon thorough study of Engineering Division on the existing condition of Bancal Pumping Station (PS) No. 3 located at Abandoned Road, Brgy. Bancal, Carmona, Cavite and by an expert opinion rendered through CCTV Underground Camera Survey Visual Report conducted last April 13, 2019 copy of which is attached hereto as Annex "B", it was determined that the static water level of the said PS is nearly reaching the total depth of the well and advised to drill more depth to upgrade the setting of its pump and motor;

WHEREAS, after careful evaluation on the above matter, it was decided to drill a new production well on the same location instead of improving the existing facility since implementing the latter might have no chance of achieving the maximum feasible depth due to several factors such as possible metal hindrances underneath caused by the previous drilling and hardened soil strata;

WHEREAS, due to time restriction and to resolve the existing problem as soonest as possible, the management decided to undertake the well drilling project through Emergency Procurement with reference to the Implementing Rules and Regulations of the Government Procurement Reform Act (RA 9184) on which Negotiated Procurement under Emergency Cases may be resorted if immediate action is necessary to restore vital public services;

WHEREAS, as per advice of the Division Manager of Finance, the CWD has Unappropriated Surplus in the amount of Fifteen Million Eight Hundred Fifty Four Thousand Seven Hundred Ninety Three and 77/100 (P 15,854,793.77) as of the end of March 2019, which is free and available for appropriation by way of Supplemental Budget;
