To proceed with the operation of a water supply and distribution system with a maximum extraction rate of not exceeding Two Hundred Thirty Eight (238) liters per second with the following project components: Forty One Thousand Three Hundred Sixty Six (41,366) linear meters distribution pipelines, Thirteen (13) pumping stations equipped with flow meters, valves, deep wells, chlorine injectors, motor pumps, generator sets, Five (5) units water storage tank, office and other related support facilities.

Implementation requirements and other conditions set forth in this Clearance are as follows:

- This Clearance may not be assigned or transferred to a new Owner without the prior written consent of LLDA;
- Any subsequent additions, alterations or changes to the originally approved plan, project or program subject of this Clearance shall be made only upon written consent of the LLDA and shall be covered by a separate or amended LLDA Clearance as per LLDA Board Resolution No. 408, Series of 2011;
- A copy of Zoning Permit or Locational Clearance from the LGU concerned shall be submitted to this Office within ninety (90) days upon receipt of this Clearance;
- All conditions stipulated in the submitted Zoning Permit and Environmental Compliance Certificate (ECC) must be faithfully complied with and in case of revocation of Zoning Permit or ECC, this Clearance shall be considered null and void;
- Fursuant to the Philippine Clean Water Act of 2004 (RA 9275), a **Wastewater Discharge Permit** shall be secured from this Office within thirty (30) days upon receipt of this Clearance if the project is already operational, or within thirty (30) days before its target date of operation, whichever is applicable;
- Any processes, fuel-burning equipment, tools and installations emitting air pollutants shall be covered by the necessary clearance or permit from DENR - EMB Regional Office, pursuant to the Philippine Clean Air Act of 1999 (RA 8749);
- The operation must comply with Ecological Solid Waste Management Act of 2000 (RA 9003), Toxic Substances and Hazardous and Nuclear Wastes Control Act of 1990 (RA 6969), and other national regulations and local ordinances on the proper disposal of solid wastes, hazardous and/or special wastes;
- In general, the implementation of such plan, program or project shall not cause significant negative environmental impact and shall ensure that critical environmental concerns are addressed to the full satisfaction of the LLDA;
- Should verified complaints arise against this project, the operation shall be suspended until corrective measures are implemented and the complaints are resolved to the full satisfaction of the LLDA; and
- This Clearance or a copy hereof should be posted in a conspicuous place within the premises clearly visible to the public for verification and guidance and shall be adequately framed or otherwise protected against damage.
