MESSAGE FROM THE GENERAL MANAGER

The year 2022 for Carmona Water District was a year of building and expanding our water facilities, and enhancing our processes, programs, and policies to establish a more efficient and increased capacity to cater the surging number of concessionaires and the growing demand for a clean and safe water service.

The year started with a common hope for all of us to finally overcome the unimaginable and harmful effects of the Covid-19 pandemic. But whatever had transpired for the past few years, CWD has remained steadfast and resilient. Not only did we surpass all the many environmental challenges we have faced, but were also able to complete notable awards and recognitions, which served as a testament to our unwavering commitment to service excellence.

However, what we are mostly proud of is our commitment to provide a transparent and efficient public service, which we inculcate in our hearts and put into action. As proof, CWD has once again passed the 2nd Surveillance Audit for ISO 9001:2015 (QMS) and ISO 14001:2015 (EMS). Also, CWD has consistently passed COA Audits over the years with outstanding and commendable results through a proper, systematic, and honest approach in preparing and presenting all our documents and policy implementation. CWD also received the Certificate of Water Safety Plan Acceptance duly approved by the Department of Health thru LWUA, according to the DOH AO No. 2017-0006. In addition to the long list of accomplishments, CWD was also recognized as having met the Level 2 Accreditation under the enhanced PRIME HRM, ensuring a labor force capable of providing excellent public service.

Through our collective effort, we are able to fulfill various construction projects which aim to expand our services and to contribute in preserving our environment. On July 8, 2022, CWD Septage Treatment Plant Facility was finally inaugurated, and we are very proud to have it operated solely by CWD personnel. Following the Municipal Ordinance No. 017-2013 as supplemented by Municipal Ordinance No. 3-2019 our agency has been given the full authority and responsibility for the collection of sludge, transportation, treatment, and disposal of treated water. CWD also installed a water tap in Carmona Columbarium and is now enjoying the free treated water. Significantly, our agency has also started the expansion of the CWD building which will be completed in the year 2023. This expansion will allow us to provide better customer service to our paying concessionaires and will enable our employees to have safer, more accessible, and enhanced facilities.

By 2023, one of our priorities is to sustain the agency's exceptional financial performance and position by maintaining the uninterrupted sequential rise of our Cash and Cash Equivalents since 2015 and making good use of our financial resources. CWD will continue to utilize the digitalization of our Meter Reading and Bill Serving and will continue to innovate and constantly improve our systems, policies, and procedures in catering services to all our concessionaires and stakeholders.

- Educate, train and motivate employees, concessionaires, suppliers and others to carry out activities in an environmentally responsible manner.



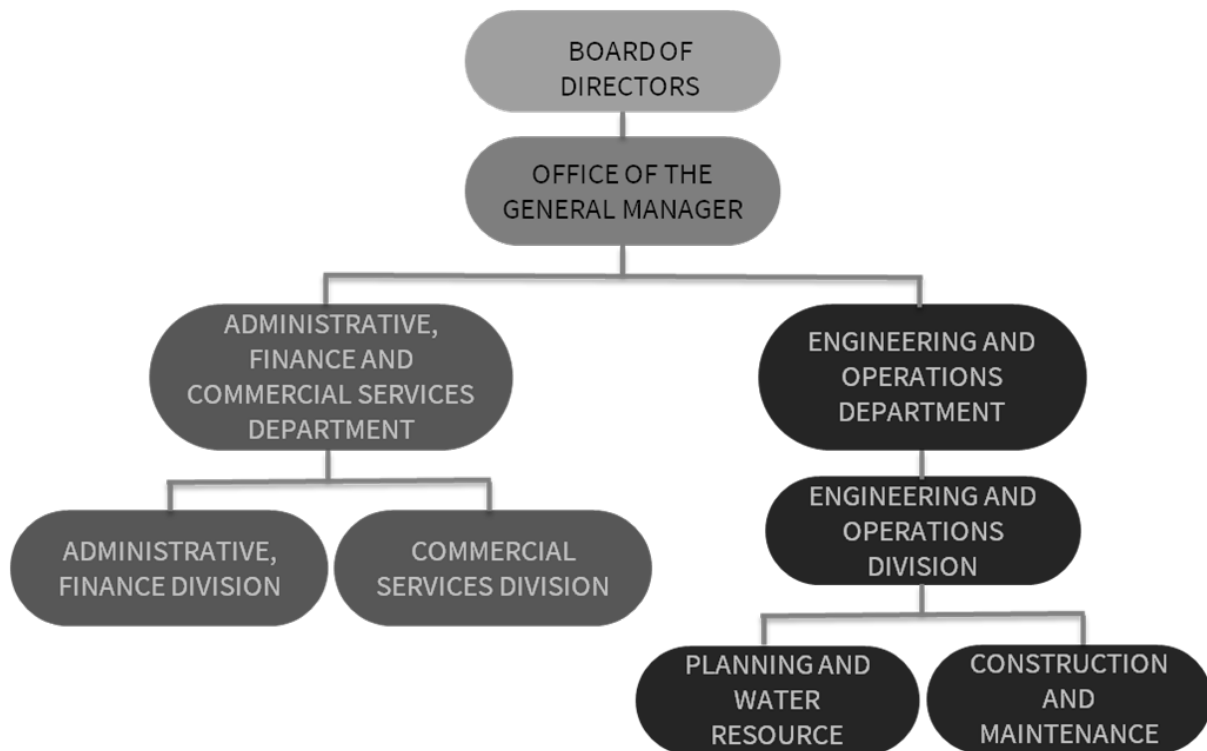

I. GENERAL

Carmona Water District Organizational Structure and Functional Statement

Carmona Water District's organizational chart is based on the approved Re-categorization to Category "B" Local Water District on February 16, 2018 by the Department of Budget and Management. The functional type chart shows the unit broad functions of the district.



Functional Statements

I. Office of the Board of Directors

The Board of Directors:

- The policy-making body of the agency;
- Responsible for establishing, adopting policies, and amending by-laws for the management and operations of the district;
- Exercising all powers, privileges and duties of the District;
- Responsible for appointing, by a majority vote, the General Manager of the District.

II. Office of the General Manager

The General Manager:

- Appointed by the Board of Directors;
- In-charge of the over-all administration and direction of the district operations towards achieving strategic goals and objectives;

- Responsible for providing overall leadership and management including planning, goal setting, evaluating District effectiveness consistent to mission and vision towards achieving strategic goals and objectives;
- Responsible for the implementation of policies and procedures, approval of program of works, direct coordination with local government and other agencies of the government;
- Responsible for the management of the district expenditures, and overseeing all programs and activities of the district.

III. Administrative, Finance and Commercial Services Department

The Administrative, Finance and Commercial Services Department is the overall support of the district operations. This composed of two (2) divisions. These are the:

- Administrative and Finance Services Division.
- Commercial Services Division.

III.a. Administrative and Finance Services Division

The Administrative and Finance Services Division is responsible for the management of human resources, administrative, and general services. It is also responsible for the transparent reporting of the agency's performance and financial position. The administrative and finance services division is:

- In-charge of personnel management, recruitment, selection, and placement, personnel reports and record management based on the guidelines of the Merit Promotion and Selection Plan;
- Responsible for handling employees' welfare and discipline, performance evaluation, compensation and benefits, incentives and awards;
- Responsible for the employee's information system, employee's relations, human resource planning, safety, and medical;
- Responsible in coordinating with other division for the staffing needs that will aid to achieve organizational goals;
- In-charge of the professional development of the water district's workforce through learning and development interventions based on the guidelines of the L&D policy;
- Responsible for the arrangement of training/seminar/workshop for the learning and development intervention of the employee that will foster knowledge and increase self-esteem.
- Responsible for assessing employee's knowledge, skills, and abilities to identify performance gaps and/or potential and in providing a specific intervention to correct the deficiencies and/or to improve in employees' performance of their duties and responsibilities.
- In-charge of property management including maintenance of building, grounds, office equipment, and vehicles.
- Responsible for the administration of supplies such as office materials and equipment, keeping track of the movement and determination of safe stock of all needed supplies.

- Responsible for managing the entire procurement process, from taking down requisitions, canvassing and purchasing of all supplies and materials needed by the agency and its personnel.
- Responsible for overseeing the record management like storage and safekeeping of the agency's records by providing areas where the records will be kept and maintained.
- Responsible for maintaining the safety, cleanliness and orderliness of the workplace and responsible for keeping the environment and place conducive for working.
- Responsible for the management of the motor pool of the agency such as dispatching of vehicles, ensuring that vehicles are good condition and having them properly cleaned and maintained all the time.
- Responsible for the implementation of all financial policies, systems, procedures, directives and proposes strategic planning initiatives and program changes.
- Responsible for all aspect of financial management including accounting, financial reporting, debt management, risk management, budgeting and planning, and ensuring compliance with existing regulatory rules.
- Responsible for handling accounts receivable monitoring and collection, account reconciliations, processing of payables, preparation of financial reports and financial analysis, and setting up adequate internal controls for business processes of the water district.
- Responsible for annual budget preparation, consolidation and monitoring that includes consolidation of estimates (revenues, capital expenditures, operating and maintenance expenses) that will account for the agency's operating, expenditures
- Responsible for comparing the actual versus budget and evaluating the results thereafter and formulation of plans and strategies, recording and balancing of cash and check collections, preparation of daily cash position, and recording of the total collection and total deposits.
- Responsible for maintaining the records of financial transactions, monitoring of assets of the corporation, reports its financial status and operations, and to comply with government reporting requirements.
- In-charge of the entire accounting process starting from bookkeeping to preparation of financial statements and evaluation and interpretation of the results thereof.
- Responsible for the preparation of reports to submit to regulating government agencies.

III.b. Commercial Services Division

The Commercial Services Division manages customer services and customer accounts. The commercial services division is:

- Responsible for attending to customer's inquiries and complaints on billing and other water services.
- Responsible for the implementation and strengthening of meter reading, billing and collection policies and activities.
- Responsible for the collection of water bills payment and preparation and consolidation of billing and collection reports (such as daily and monthly collection report remitted to cashier).

- Responsible for the processing of customer accounts, updating of concessionaires' data, preparation of statement of accounts.
- Responsible for the monitoring of unpaid bills as well as preparation of individuals notices of disconnection, and generation of the division's reports.
- Responsible for the preparation of the annual projected revenues and safekeeping of all official receipts copy and file copy of collection reports.
- Responsible for the processing all activities for the billing preparation such as meter reading, encoding, generation of bills, billing cycle and zoning of barangays, materials for meter reading, and posting of water consumption.
- Responsible for handling new service connection applications and prepare service request forms, issuance of work orders, disconnection, and reconnection.
- Responsible for attending to customer's complaints, requests and feedback from the concessionaires for district's improvement on customer relationship.
- Responsible for checking and recommendation on service connection for reclassification, repair or illegal connection.
- Responsible for the safekeeping of concessionaires' record and other documents related to the division.

IV. Engineering and Operations Department

The Engineering and Operations Department is in charge of construction and maintenance of water services facilities, wastewater sanitation and water resource operations.

IV.a. Engineering and Operations Division

The Engineering and Operations Division is responsible in handling water production, supply and quality control including the wastewater sanitation. It also responsible for the implementation of water services infrastructure and projects. It has three sections which include:

i. Construction and Maintenance Section

- This section is in-charge for the construction and maintenance of the district water services facilities, distribution lines, and service connection lines.
- This section is responsible for the installation of new water service connections.
- This section is responsible for performing the actual investigation process including the computation of bill of materials, monitoring and repair of leaks on service connection lines, distribution lines, and mainline pipes.
- This section is responsible for attending to service requests and concessionaire complaints like request for relocation of water meters, transfer and reclassification of service lines.
- This section is responsible for the inspection of the applied new service connection for costing and preparation of materials needed for the installation.

ii. Planning and Water Resources Section

- This section is responsible for the maintenance and operation of all pumping stations to ensure sustainable supply of potable water to all concessionaires.
- This section is responsible for the preparation of the District Metered Area (DMAs) to efficiently distribute water supply across the city.
- This section is responsible for the monitoring of the quality of water produced through water treatment, preparation and collection of water samples for various tests, and conducting quality testing.
- This section is responsible for the planning of infrastructure projects and program preparation for the district incorporating studies and researches for the development and improvement of the water system. It comprises short and long term planning for the expansion projects and efficient systems for the water district.
- This section is responsible for the submission of the mandatory reportorial requirements of the governing agencies in compliance for the potable, adequate and economical water supply to concessionaires.

iii. Waste Water Treatment Section

- This section is responsible for the collection and transportation of septage from the concessionaires to treat waste water using the advance wastewater treatment technology and to reuse the treated water for utility purpose and the proper disposal of the sludge;
- This section is responsible for the operation of CWD Laboratory, which performs water quality testing before the treated water is used again;
- This section is responsible in ensuring that the treated water meets the standards for effluent water under the governing laws, rules and regulations of the governing agencies.
- This section is responsible for the submission of the mandatory reportorial requirements of the governing agencies for the environmental compliances.

II. PROFILE

A. THE WATER DISTRICT AND ITS PHYSICAL SYSTEMS FACILITIES

1. ORGANIZATION

Brief History of Carmona Water District

Carmona Water District is a non-profit, government-owned and controlled corporation which was established to provide water services under Level III System to the municipality of Carmona with more than 20,000 populations.

Municipal Resolution No. 077-96 dated October 14, 1996 gave way to the birth of Carmona Water District (CWD). Under this resolution, CWD shall have exclusive power to raise revenues and promulgate rules and regulations to run and manage the water utility pursuant to the provisions of Section 27, Title II of Presidential Decree 198 known as the Provincial Water Utilities Act of 1973.

Later on, the Sangguniang Bayan of Carmona amended this resolution on January 20, 1997 under Municipal Resolution No. 002-97 creating CWD and designating its Board of Directors. Since CWD was still a non-self-supporting utility at that time, the Local Government of Carmona provided a monthly subsidy of Php15,000.00 for a period of 1 year to help the district implement an improved staffing pattern and operational format.

On **April 27, 1997**, the Local Water Utilities and Administration (LWUA)—an agency created to assist provincial urban water-users through loans, training and other forms of assistance, awarded a **Certificate of Conditional Conformance Number 561** to CWD. This marked the inception of CWD with its first General Manager, Engr. Teddy Medina, who served the district for 2 years. He was succeeded by Mr. Edison L. Sarmiento, Jr. who served from the year 2000 until October 2015.

Consequently, starting November 2015, **Engr. Aniline B. Francia** assumed the General Manager position and has been bringing positive changes to the District.

With CWD growing rapidly, delivering sufficient, clean and economical water to its increasing number of concessionaires has been a challenge. But through the hard work of its employees and good leadership, CWD has surpassed these challenges. In August 2006, CWD was categorized by LWUA from Small to Big Category having reached a remarkable 5,000 service connections. This had been a big leap for the district.

In 2012, CWD was successfully re-categorized by LWUA from Category “C” into **Category “B” Water District** having reached more than 13,000 concessionaires. This was ratified by the Department of Budget and Management (DBM) on February 2018.

After almost 25 years in public utility service to the town of Carmona, CWD has greatly improved from just starting with a single well. Now, the district has **nineteen (19) Pumping Stations** located within the 14 Barangays being served.

Through the years, Carmona Water District has continuously met its objective of supplying clean, sufficient and economical water to its concessionaires.

2. EXISTING SYSTEM FACILITIES

Carmona Water District’s 100% water supply comes from groundwater sources. Its nineteen (19) deep-wells operate using water pump and motors. Water is being treated through chlorination to make it potable. Pumped water is either stocked into elevated tanks or flows directly to the main distribution lines up to the concessionaires’ faucets.

3. FINANCIAL HIGHLIGHTS

Carmona Water District attained the following financial highlights for the year 2022.

Financial Performance:

- A 2.60% increase on total service and business income from P124.52M FY 2021 to P127.76M;
- Personnel Services was increased from P34.73M FY 2021 to P35M;
- Maintenance and Other Operating Expenses was also increased from P29.90M FY 2021 to P36.44M;
- Total discounts and rebates granted was P1,014,164.16;
- Net income was decreased by 14.83% from P52.63M FY 2021 to P44.82M.

Financial Position:

- A 13.61% increase on cash and cash equivalents from P165.59M to 188.13M;
- Investments in Time Deposits and Retail Treasury Bonds were recorded amounting to P25M and P50M, respectively;
- Property, Plant and Equipment was increased by 28.47% from P118.86M FY 2021 to P152.70M;
- An increase by 14.23% on total current liabilities from P5.93M FY 2021 to P6.77M;
- Retained Earnings was increased by 12.22% from P349.59M to P392.29M.

Other significant highlights:

- Net Income Ratio of 0.35 was achieved as against to benchmark of greater than .08;
- Operating Ratio is still favorable at 0.65 vs. not more than .75;
- Overwhelming current ratio of 34.75:1 as against the standard of 1.5:1;
- Cash to debt ratio of 8.67;

- Collection Efficiency of 98.10% was realized as against to the benchmark of 90%.

C. COMMUNITY ECONOMIC PROFILE

1. Based on the 2015 Philippine Statistics Authority census, Carmona has a total population of 97,557. With the anticipation of 2.2% increase per year, Carmona has projected total population and total households of 111,164 and 22,233, respectively, by the end of 2021. Considering the estimates against the total active connections of 15,098 of the same year, Carmona Water District provides adequate and potable water supply to 67.91% of the entire Carmona population. However, if the total service connections as of 12/31/2021 are to be taken into consideration, CWD covers 74.70% of its franchise area. While the water supply demands of the remaining households are currently provided by other private service providers, CWD is still aiming to deliver at 100% full service households coverage.

Paul Christian S. Mantilla, and Engineering Asst. Khrysstine Bernadette M. Bravo. Present also from Kalinisan Chemicals Corp. were Dir. The rain harvester units can hold up to 800 liters of water. These harvesters can be found in Phase 3 Covered Court and Phase 4 Health Center of Brgy. Milagrosa. The accumulated water can only be used for watering plants, cleaning of road, etc.

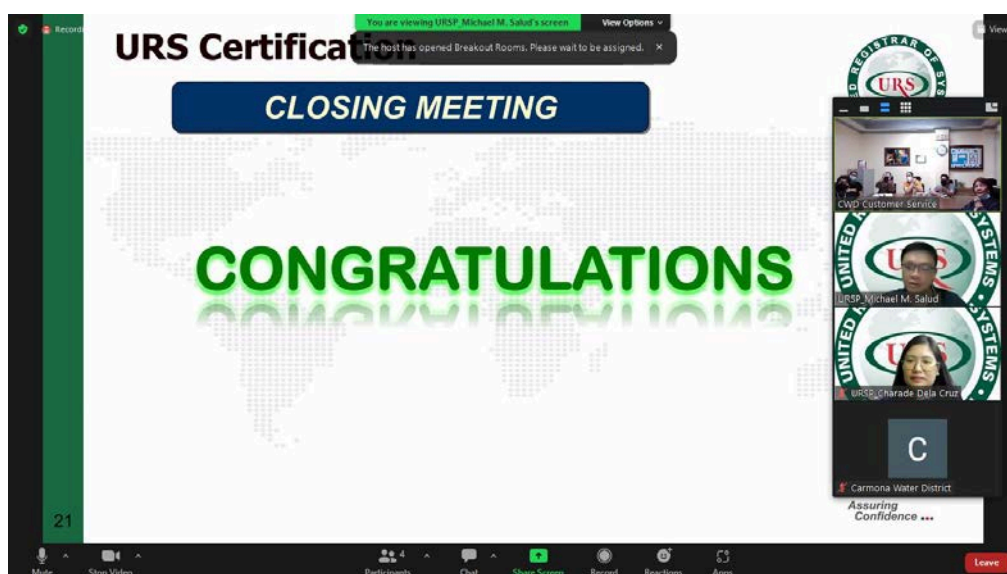

The program started at the Penthouse of the Municipal Hall of Local Government of Carmona, with an AVP presentation prepared by the Carmona Water District, which exhibited the concept behind the SpTP project construction and a walkthrough prior to its inauguration on July 8, 2022. All participants then proceeded to the CWD Septage Treatment Plant Facility, for the actual tour of the facility, in which the hosts proudly guided all participants and explored the different parts of the facility, its safety and security features, as well as the materials and machineries used for its operation.

The establishment of Carmona Water District's Septage Treatment Facility was formulated through the different laws and mandates such as the Clean Water Act of 2004, the National Sewerage and Septage Management Program (NSSMP), Water District Law or the PD 198 Sanitation Code and Municipal Ordinance No. 017-2013 as supplemented by Municipal Ordinance No. 3-2019 became the basis of compliance for the construction and implementation of Septage Treatment Facility.

The construction of SpTP underwent a Public Bidding last December 2020 using the agency's Corporate Fund. The SpTP has a capacity of 20 cmd and it is still expandable to twice its capacity due to an additional 20 cmd holding tank. The treatment will be up to tertiary process in accordance with DAO 2016-08 and DAO 2021-19. The project was then awarded to Chemical Research Products Industrial Sales, Inc. last March 9, 2021, followed by a Notice to Proceed signed last April 7, 2021. CWD Management also ensures compliance with laws by securing permits and licenses needed for its operation.



15. Carmona Water District Observes 2022 18-Day Campaign to End Violence Against Women and the Republic Act 11313: Safe Spaces Act or the Bawal Bastos Law

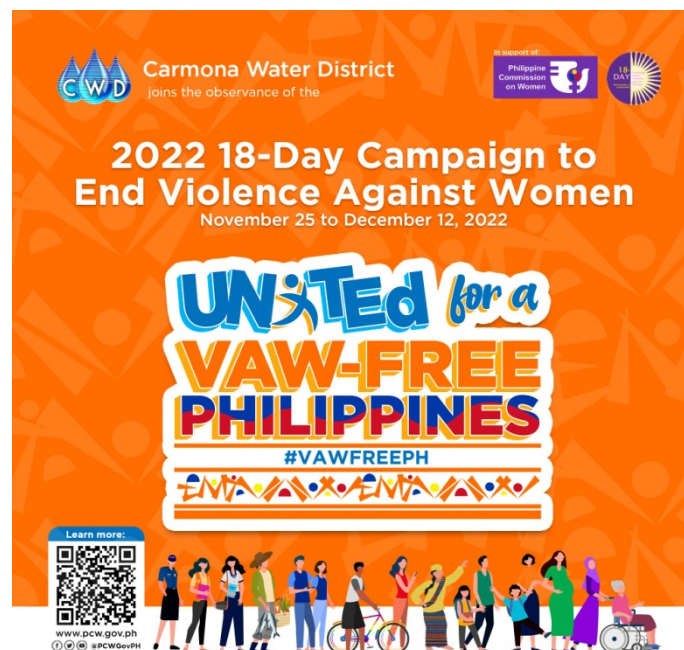

This helped increase the social awareness of all CWD employees pertaining to the recognition of women's rights covered by various laws and the establishment of institutional mechanisms to address VAWC.




18. Carmona Water District in partnership with Land Bank of the Philippines

Carmona Water District through Board Resolution No. 019-2022 dated July 14, 2022, was authorized to enter into Memorandum of Agreement (MOA) in partnership with the Land Bank of the Philippines as collecting agent of payments for water bills.

The LBP, using their Link.Biz Portal, can collect payment for water bill from the concessionaires of CWD. Account holder of Land Bank of the Philippines or other banks user can pay their water bills by accessing the Link.Biz Portal. A step-by-step process on how to pay water bills using Link.Biz Portal is posted in CWD social media account and website.
